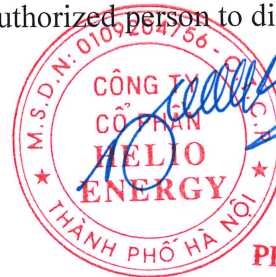

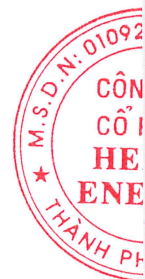

Pursuant to the plan for capital utilization from the offering, on March 16, 2026, the Board of Directors issued Resolution No. 05/2026/NQ-HDQT regarding the approval of the share transfer transaction at SD Truong Thanh Joint Stock Company. Accordingly on the same day, the Company proceeded to acquire 17,795,102 shares with a total value of VND 210,000,000,000, representing 59.32% of the charter capital of SD Truong Thanh Joint Stock Company from 03 transferring shareholders, and completed the contract liquidation on March 30, 2026.
